5 ESTABLISHING THE JOINT LEGISLATIVE COMMITTEE TO
6 STUDY SELF-DRIVING VEHICLES.

8 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
9 HOUSES THEREOF CONCURRING, That there is established the Joint
10 Legislative Committee to Study Self-Driving Vehicles.

11 (a) The committee shall be composed of the following
12 members:

13 (1) Four members of the Alabama Senate appointed by
14 the Senate President Pro Tempore.

15 (2) Four members of the Alabama House of
16 Representatives appointed by the Speaker of the House of
17 Representatives.

18 (b) The committee membership shall be inclusive and
19 shall reflect the racial, gender, geographic, urban/rural, and
20 economic diversity of the state.

21 (c) The goals of the committee are to study all
22 aspects of self-driving vehicles, including specifically, the
23 issues of public safety and state and local economic impact
24 regarding such vehicles. The study committee shall assess the

1 extent to which existing state legislation may impact the
2 ability for testing of automated vehicles in the state.

3 (d) The committee shall report its findings and any
4 proposed legislation, including the testing of automated
5 vehicles, to the Speaker of the House and the President Pro
6 Tempore of the Senate not later than the tenth day of the 2017
7 Regular Session, whereupon it shall stand dissolved and
8 discharged of any further duty or liability. The study
9 committee shall engage with key industry stakeholders in the
10 development of its findings.

11 (e) Upon request of the chair of the committee, the
12 Secretary of the Senate and Clerk of the House of
13 Representatives shall provide necessary clerical assistance
14 for the work of the committee.

15 (f) Each member of the committee shall be entitled
16 to his or her regular legislative compensation, per diem, and
17 travel expenses for each day he or she attends a meeting of
18 the committee in accordance with Amendment 871 of the
19 Constitution of Alabama of 1901. These payments shall be paid
20 out of any funds appropriated to the use of the Legislature.
