- Supervises, performs, and directs specialized technical work on City transportation projects.
- Oversees the technical research, planning, design, estimating, contracting, constructing, permitting and/or monitoring of City projects (e.g., traffic, construction, street lighting, bridges, ramps for the disabled, etc.).
- Represents the Department of Mobility and Infrastructure by attending City Council meetings, work sessions, retreats, neighborhood meetings, and local and regional boards and commissions; prepares agenda items and/or reviews agenda items prepared for council meetings, boards and commissions.
- Oversees budget preparation by guiding the development of annual departmental operating budgets; develops and prioritizes capital improvement program project requests; ensures the proper monitoring and reporting of budget revenues and expenses.
- Manages the activities of transportation planning and is responsible for the development and implementation of a strategic and comprehensive long-term transportation plan for the City.
- Maximizes investments and seeks additional funding for community projects from local, state, and federal resources.
- Evaluates and advises on State and Federal legislative proposals related to transportation.
- Supervises assigned personnel; evaluates work; recommends and implements approved disciplinary and/or corrective action; provides training and/or technical assistance as requested or required.
- Manages area of responsibility in strict accordance with applicable laws, regulations and established policies, including union agreements.
- Oversees major services, transportation planning, and traffic engineering for a successful multimodal system.
- Cultivates strong partnerships and coordination to create external and internal partnerships.
- Assists in the resolution of engineering and construction problems; interacts with other departments, contractors and public organizations regarding projects.
- Supervises, coordinates and directs information gathering, processing and archiving of the City's physical assets and record drawings.
- Plans, develops, directs, coordinates, organizes and controls the materials, equipment and personnel under jurisdiction toward the effective, efficient and economical attainment of program goals including maximum convenience to the public and safety of employees.
- Directs and oversees the Department of Mobility and Infrastructure's programs and service functions including the planning, construction, and operation of the City's traffic control infrastructure, street lighting, multi-modal transportation planning, traffic engineering, and development review functions.
- Coordinates with maintenance division as necessary for project completion.
