Ordinance No. 021231 Council Bill No. B 25-12 A

AN ORDINANCE

amending Chapter 14 of the City Code as it relates to taxi stands and no pick-up or drop-off zones; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 14-295. Taxi stands designated.

When signs are placed, erected or installed giving notice thereof, the following zones shall be designated as ~~taxi stands~~ for designated vehicles only and; no person shall park a vehicle other than a taxi, ~~limousine, bus or STRIPES vehicle between 9:00 p.m. and 2:30 a.m.~~ in any place marked as a taxi stand:

Broadway, north side, between Waugh Street and a point 280 feet east of Waugh Street.

Cherry Street, south side, between Hitt Street and Tenth Street.

Locust Street, north side, between Ninth Street and Tenth Street.

Ninth Street, west side, first four spaces south of Elm Street.

Tenth Street, east-west side, between Broadway and the alleyway just north of Broadway from a point forty-three (43) feet south of the northeast corner of Tenth Street and Ash Street, thence south forty-four (44) feet.

Tenth Street, east side, between 10:00 p.m. and 3:00 a.m., from a point seventy-five (75) feet north of the northeast corner of Tenth Street and Broadway, thence north forty-five (45) feet.

14-355. No pick-up or drop-off zones.

When signs are placed, erected or installed giving notice thereof, the following zones shall be designated as no pick-up or drop-off zones and no person driving a motor vehicle shall drop-off or pick-up passengers, between 10:00 p.m. and 2:30 a.m., in any place marked as a no pick-up or drop-off zone:

Broadway, both sides, between Seventh Street and Short Street.

Cherry Street, both sides, between Ninth Street and Tenth Street.

Hitt Street, both sides, between Broadway and Cherry.

Ninth Street, both sides, between Walnut Street and University Avenue.

Sixth Street, both sides, between Broadway and Walnut Street.

Tenth Street, both sides, between Broadway and Locust Street.

Secs. ~~14-355-14.356~~—14-370. Reserved.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.
