**MOTION FOR PARTY STATUS OF THE SAN FRANCISCO COUNTY

I. Introduction

The San Francisco County Transportation Authority (SFCTA) respectfully moves for party status in this proceeding in accordance with Section 1.4 of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure.

II. Interest in this Proceeding

A. The SFCTA is the Congestion Management Agency for the City and County of San Francisco, with the responsibility to monitor and manage congestion and multimodal transportation performance. The SFCTA is also responsible for managing and programming transportation grants from local, state and federal sources.

B. The SFCTA has an interest in providing input to the California Public Utilities Commission’s (CPUC’s) rulemaking on Transportation Network Companies’ (TNC’s) related to data-sharing policy regarding TNCs in order to ensure that we have ongoing access to appropriate and sufficient data to analyze the TNC transportation market sector and its impacts

and benefits to congestion and multimodal performance. The SFCTA is also interested in providing input related to safety and TNCs and to ensure San Francisco meets its goal of Vision Zero.
